Accountabilities:	 management framework and field support as required for all fleet (HVGs and a diverse fleet of LGVs) in the Sol Group as per the following focus areas: Policy Liaison with Parkland Fleet management team to align on general framework and develop specific fleet replacement strategy, maintenance guidelines, KPIs etc. for Sol. Update and maintain Sol's Road Transportation Goods and Equipment Guidelines Policy. Road Transport HSE Case (Risk Register) – responsible for updating and maintaining Sol's Corporate Road Transport Case, and providing support to develop/maintain market RT cases. Regulatory compliance – verify local transportation regulatory requirements and ensure that company guidelines meet or exceed the same.

- Develop and maintain framework for technical specifications of company vehicles and providing guidance on requirements for 3rd party vehicles.
- o Vendor relations Primary Sol contact for 3rd party vendors, original equipment manufacturers and tank body upfitters.

- o Align and implement Parkland Global Procurement Strategy/Guidelines for Sol procurement requirements.
